## NOTICE OF REGULAR MEETING

The City Council for the City of Olmos Park, Texas will meet in a regular session on Wednesday, January 20, 2021 at 6:00 p.m. in the Council Chambers at City Hall for the purpose of considering the following agenda:

- **2.** Citizens to be heard: This time is provided for citizens to address the Council on issues and concerns. No action can or will be taken on issues raised under this portion of the meeting. Please state your name and address for the record and limit your remarks to a period not to exceed three minutes.
- **3.** Discuss and take possible action on an Ordinance 2021-01 of the City Council of the City of Olmos Park, Texas ordering a general election to be held jointly with Bexar county on May 1, 2021 for the election of city council place #1, city council place #2 and city council place #3 to serve a two year term; designating the main early voting place for such election; authorizing the mayor to enter into a contract with Bexar county elections administrator providing for an order and notice of such general election; providing a severability clause; and providing an effective date.
- **4.** Public Hearing on a request from AERC Investments, LLC & AERC Investments II, LLC for a Special Use Permit on three (3) adjacent properties in the Local Retail District, allowing the following otherwise prohibited uses:
  - 1) 4349 McCullough Ave. to allow both Veterinary Practice/Animal Clinic and Animal Boarding;
  - 2) 110 Agnes Drive to allow both Veterinary Practice/Animal Clinic and Animal Boarding; and,
  - 3) 4351 McCullough Ave. to allow both Veterinary Practice/Animal Clinic and Animal Boarding in lieu of current legal non-conforming ("grandfathered") status.
